#### ENVIRONMENTAL AND SOCIAL COMMITMENT PLAN

- Agricultural Projects Implementation Unit (APIU) will implement the One Health for Pandemic Prevention Food Systems Resilience and Ecosystem Heath in Central Asia P181459 as Phase 1 of the Multi-Phase Programmatic Approach program (the Project), with the involvement of five implementing entities, including the Ministry of Water Resources, Agriculture and Processing Industry, the Ministry of Health, the Ministry of Natural Resources, Ecology and Technical Supervision, and the National One Health Coordination Structure, as set out in the Pandemic Fund Grant and Financing Agreement. The International Development Association [the Association] and the multicountry Pandemic Fund grant [PF] has agreed to provide financing for the Project, as set out in the referred Agreement.
- 2. The Recipient shall ensure that the Project is carried out in accordance with the Environmental and Social Standards (ESSs) and this Environmental and Social Commitment Plan (ESCP), in a manner acceptable to the Association. The ESCP is a part of the Agreement. Unless otherwise defined in this ESCP, capitalized terms used in this ESCP have the meanings ascribed to them in the Agreement.
- 3. Without limitation to the foregoing, this ESCP sets out material measures and actions that the Recipient shall carry out or cause to be carried out, including, as applicable, their respective timeframes; institutional, staffing, training, monitoring and reporting arrangements; and grievance management. The ESCP also sets out the environmental and social (E&S) documents, consisting of an Environmental and Social Management Framework (ESMF), including a template for a Laboratory Biosafety and Waste Management Plan (LBWMP), a Stakeholder Engagement Plan (SEP), a Labor Management Procedure (LMP), and a Resettlement Policy Framework (RPF). These documents shall be adopted and implemented under the Project, all of which shall be subject to prior consultation and disclosure, consistent with the ESSs, and in form and substance, and in a manner acceptable to the Association. Once adopted, said E&S documents may be revised from time to time with prior written agreement by the Association. As provided for under the referred Agreement, the Recipient shall ensure that there are sufficient funds available to cover the costs of implementing the ESCP.
- 4. As agreed by the Association and the Recipient, this ESCP will be revised from time to time, if necessary, to reflect adaptive management of Project changes or unforeseen circumstances or in response to Project performance. In such circumstances, the Association and the Recipient agree to update the ESCP to reflect these changes through an exchange of letters signed between the Association and the Recipient's Representative specified in the Agreement or [the Director of the Agricultural Projects Implementation Unit] The Recipient shall promptly disclose the update ESCP.
- 5. The subsection on "Indicators for Implementation Readiness" below identifies the actions and measures to be monitored to assess Project readiness to begin implementation in accordance with this ESCP. Nevertheless, all actions and measures in this ESCP shall be implemented as set out in the "Timeframe" column below irrespective of whether they are listed in the referred subsection.
